Data from 165 surveys on fair trial standards conducted from April to July, 2017, among justice officials and members of the public in the Kyrgyz Republic.

Survey of Young People in Egypt (SYPE) is a survey amongst a nationally representative sample of young people in the Middle East and North Africa. The 2009 survey included 15,000 young people between the ages of 10 and 29 from 11,000 households. The 2014 survey follows more than 10,000 original respondents. The survey collects gender-disaggregated information on health, schooling, employment, and civic engagement.

Minutes of five discussions from meetings with groups of experts, academics, officials and students in four Eastern European countries: Armenia, Ukraine, Moldova and Georgia. Discussions focused on the role of the EU in promoting domestic reforms in these eastern neighbourhood countries. Four case studies explored four sectors: food safety, state aid, gas market and visa liberalisation. Discussions took place in Armenia, Georgia and Moldova and two in Ukraine, between March 2013 and June 2014.

The Millennium Villages Project (MVP) is a 'proof of concept' project to support African rural communities in meeting the Millennium Development Goals (MDGs). Scientists in agriculture, nutrition and health, economics, energy, water, environment and information technology, working together with communities, local partners, and governments empower and backstop villages to accelerate progress in achieving the MDGs. In the survey rounds of 2012, 2014 and 2016 the full MVP package of questionnaires were administered by the Earth Institute to track progress on the MDGs. The additional survey rounds of 2013 and 2015 administered a restricted version of the MVP household questionnaire focusing on tracking progress in poverty reduction.
